National Taipei University of Education (hereinafter referred to as NTUE), a university whose address is at Heping East Road, Da'an District, Taipei City, Taiwan, and shall be represented by **Dr. Shin-Jen Chang** as the President

and

Syiah Kuala University (hereinafter referred to as Unsyiah), a university whose address is at Jalan Teuku Nyak Arief, Darussalam, Banda Aceh, 23111, Indonesia, and shall be represented by **Prof. Dr. Ir. Samsul Rizal, M.Eng.** as the Rector

NTUE and Unsyiah shall individually be referred to as a "**Party**" and collectively as "**the Parties**".

WHEREAS:

National Taipei University of Education, Taiwan and Syiah Kuala University, Indonesia, with the objective of facilitating mutual friendship, academic research and educational cooperation between the two institutions, hereby conclude this agreement.

Article 1

Objective of Agreement

National Taipei University of Education and Syiah Kuala University will cooperate in promoting both academic research and enhancing educational opportunities for students.

Article 2

Scope of Agreement

In order to promote the cooperation as referred to in Article 1, the two institutions may undertake various activities such as those listed below. The details of the collaboration will be specified through separate negotiations.

- (1) Exchange of faculty members and researchers
- (2) Exchange of students
- (3) Organization of joint research projects, including conferences and meetings
- (4) Exchange of information and publications
- (5) Other activities mutually agreed upon by the two institutions

Article 3

Renewal and Withdrawal

This agreement shall become effective on the date of signature by the representatives of the two institutions, and will be effective for a period of five (5) years and shall be automatically renewed for another five (5) years unless either party undertakes in writing to withdraw from the agreement. A written declaration of withdrawal must be made no later than six(6) months before the termination of a given five(5)-year program.

Article 4

Amendment

Amendments to this agreement may be made by mutual written consent of the two institutions.

Article 5

Termination

This agreement may be terminated upon (six(6)) months' written notice by either side.


Article 6


Non-binding nature of agreement


This agreement shall not bind either institution to any financial commitment.
